1. The Quotations should reach to the office of the undersigned on or before **19-12-2018** up to **3.00 PM** from the date of publication by hand or registered post.
2. Opening of Tender: - Bid (including financial bid) will be opened on 19/12/2018 at 04.00 PM (if possible) or any other notified date in presence of bidders or their authorised representative who wishes to remain present.
3. Earnest Money Should be deposited in the shape of "Deposit- at – Call" or "Demand Draft" from United Bank Of India or any Scheduled bank of India Guaranteed by the RBI In Favor of The Member Secretary, IMC of ITI Belonia. The Deposit – at – call or demand draft must be submitted along with the quotation.

4. **Balance bid money** to be deposited in the shape of “**Deposit- at – Call**” or “ **Demand Draft**” on schedule bank of India garneted by the RBI In Favor of **The Member Secretary, IMC of ITI Belonia** within 3 days of issue of notice of the acceptance of the bid.
